THIS AGREEMENT is made this ___ day of _____, 200___, by and between Tasha Johnson, hereinafter referred to as "Hard Luck Horses" and _____, hereinafter referred to as "Adopter". This agreement pertains to the lease of the equine listed above, hereinafter referred to as "Equine"

Use of Equine: Equine is to be used for companionship, riding, and non-professional competition. Equine is under no circumstances to be bred. Should Equine be bred, then Adopter is in violation of this agreement and Equine must be immediately returned to Hard Luck Horses along with any resulting offspring. All rights to any offspring will belong solely to Hard Luck Horses.

Care of Equine: Adopter agrees to provide responsible care for Equine. This includes yearly vaccinations, dental floats and full examinations. Should Equine become ill or injured, Adopter agrees to immediately contact Hard Luck Horses and to have a vet examine Equine. Adopter agrees to care for Equine as directed by their veterinary professional. Adopter also agrees to provide regular hoof care and to have a qualified farrier trim Equine's hooves at no longer then 8 week intervals unless advised otherwise by Adopter's vet or farrier.

Information: Adopter agrees to provide Hard Luck Horses with bi-yearly updates and full body photos. Adopter also agrees to release any vet, farrier, trainer, or boarding facility to provide information pertaining to Equine upon Hard Luck Horses' direct request. Adopter has provided Hard Luck Horses with their vet and farrier information, however should there be any change in vet or farrier, Adopter agrees to immediately notify Hard Luck Horses. Adopter agrees to allow Hard Luck Horses to examine Equine, Equine's living quarters and any related spaces upon request. The purpose of any examination would be to ensure the continued acceptable care of Equine and to ensure that the terms of this contract are being upheld. If Equine is not being adequately cared for as per this contract and vet and farrier recommendations, Adopter agrees to surrender Equine to Hard Luck Horses without any refund of adoption fees. Should ownership of Equine be transferred, the full conditions of this contract must be agreed to and transferred to the new owner.

Liability: Adopter agrees to pay all expenses relating to Equine after the date of this agreement; including any transport or boarding charges. Adopter is responsible for any damage, injury or accident involving Equine. Hard Luck Horses is not responsible for any damage, injury or accident involving Equine.

Law: This agreement shall be governed by the laws of King County in the State of Washington. Any legal action must be filed in the county of King. Adopter and Hard Luck Horses both agree to attempt Mediation and Arbitration of any disputes relating to this agreement.
